Petition

Objection to vaccine passport entry, including restaurants, schools, recreational facilities (including movie theatres, gyms, etc.).

First We want to make clear. We have no political agenda, we are not defending our personal freedoms for the sake of personal freedom but as our fundamental right. We have no financial interest in this endeavour.

We are very concerned with our health and that of the public. Our position is based on scientific facts from our studies of relevant materials in research papers, books, and many video interviews with scientists and doctors.

We are strongly opposed to the further measure to require vaccination for entering restaurants, cinema, gyms, clubs, bars, shops etc. for the following reasons:

- 1. The vaccination programmes against covid-19 are not achieving the goal to attain herd immunity as countries like Israel, UK & Singapore, that have highly vaccinated populations continue to see higher infections rates of the omicron variant. Omicron is much more contagious but is much milder than Delta. CDC now admits that the vaccine does not prevent infection nor transmission and only lessons the symptoms.
- 2. There are potential serious side effects from the vaccines that are still under emergency use authorisation. VAERS data alone shows over 21,002 deaths and over 1,000,227 serious adverse events including 35,650 permanently disabled have occurred in the USA after the covid vaccines administration.
- 3. Strengthening the body's natural immunity is a more effective approach. Science has already proven certain natural supplements such as vitamin C, D3, zinc, quercetin, herbs such as pine needle extracts, essential oils such as eucalyptus, and traditional Chinese herbs can help prevent and treat Covid-19 or other flu viruses effectively.
- 4. In October 2020, three prominent epistemologists from Harvard, Oxford and Stanford including one Nobel prize winner have proposed a better way to deal with Covid-19 in the Great Barrington declaration. They gathered support from 50,000 doctors and scientist and 800,000 more from the public. They propose a different strategy. We should offer "focused protection " to the at risk group. The high risk group has a thousand times more deaths than the young and healthy. Also 40% of deaths occurred in nursing homes in elderly with comorbidities, such as diabetes, cancer, cardiovascular conditions, and asthma. These populations should be protected while the young and healthy should be allowed to live their lives normally.
- 5. Herd immunity can be achieved with focused protection to minimize casualties. With Covid-19 or any infectious disease the concern is the death rate. We accept the seasonal flu because it's death rate is low. 0.1-0.2 %. Despite vaccination people still catch the flu and die and the flu viruses keep mutating as nature intended but we never shut down the entire society because of the flu. If we can treat Covid-19 with effective medicines to reduce the death rate to near zero, we do not need to use to use masks, quarantine, social distance, or vaccination with potential risks of side effects. They have tried this for two years already in many countries and it's clearly not working. The social and economic costs are too high and it's not sustainable. Our youth has suffered because of these measures and we have seen an exponential increase in mental health issues. The Amish in Pennsylvania has already done that. They share drinking vessels in the church community to quickly infect more people with Covid 19 and treatments and in doing so achieved natural herd immunity.
- 6. There is a misconception that vaccination is the only way because we have no effective drugs to treat Covid-19. There are in fact many effective ways to treat viral infections for covid. India effectively used Ivermectin to turn the tide around and not mass vaccination. The original Covid-19 outbreak in Wuhan was successfully turned around with the use of traditional Chinese medicine not just quarantine. We can also use the example the original SARS outbreak where a Chinese traditional medical team treated 730 cases, with zero death, zero transfer, zero sequela. That is why many other countries with similar drastic measures cannot produce the same result as China. They lack the key element- the effective treatment with traditional Chinese medicine.
- 7. In the book 'Every Second Child' by Archia Kalokerinos, an Australian doctor given the task of vaccination for Australian native aborigine children found that they would die after receiving their childhood vaccinations to the tune of 50%. The doctor realized that this is because the children are undernourished and immune

compromised. He solved this problem by giving the children vitamin c before vaccination. Following this all the Children survived the vaccination program.

8. Historically In the 1918 flu pandemic, 50 million or more people died. 1/3 of the world population were infected. Hospitals records dug up by Dr. Thomas McCann showed that of 24,000 cases treated in the allopathic hospital, the death rate was 28.2 %. With another 26,000 cases treated in the homeopathic hospitals the death rate was only 1.05 %. Before antibiotic. Pneumonia was treated with ultraviolet rays irradiation on drawn blood from patients. One study of ten cases had 100% success rate.

Let us adopt a different strategy to deal with Covid-19. Vaccination is not the answer. Enough is enough.
